2. Terms and Legal Basis

2.1 Terms

Personal data is any information that relates to an identified or identifiable person. An affected person is a person whose personal data is processed.

Processing includes any handling of personal data, regardless of the means and procedures used, in particular storing, disclosing, obtaining, collecting, deleting, storing, changing, destroying, and using personal data.

2.2 Legal Basis

We process personal data in accordance with Swiss data protection law, particularly the Federal Act on Data Protection (FADP) and the Ordinance to the Federal Act on Data Protection (OFADP).

Contact Forms

The data you enter will be stored for the purpose of individual communication with you. A valid email address and your name are required for this purpose. This is used to assign the request and subsequently respond to it. Providing additional data is optional.

Embedded Content from Other Websites

Social Plugins

Social media plugins are used on our websites. Information, including personal data, may be sent to and possibly used by the service provider through these plugins. We prevent the unintentional and unwanted collection and transmission of data to the service provider through a 2-click solution. To

activate a desired social plugin, it must first be activated by clicking the corresponding switch. Only by activating the plugin will the collection of information and its transmission to the service provider be triggered. We do not collect any personal data via the social plugins or through their use.

We have no control over what data an activated plugin collects and how it is used by the provider. Currently, it must be assumed that a direct connection to the services of the provider is established and at least the IP address and device-related information are collected and used. There is also the possibility that the service providers try to store cookies on the used computer. Please refer to the privacy policies of the respective service providers for what specific data is collected and how it is used. If you are simultaneously logged in to Facebook, Facebook can identify you as a visitor to a particular page.

Google AdWords

Our website uses Google Conversion Tracking. The operator of Google AdWords services is Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA. If you access our website via a Google ad, a cookie will be set on your computer by Google AdWords. The cookie for conversion tracking is set when a user clicks on an ad placed by Google.

If the user visits certain pages of our website and the cookie has not expired, we and Google can recognize that the user clicked on the ad and was redirected to this page. Each Google AdWords customer receives a different cookie. Cookies cannot be tracked via the websites of AdWords customers. The information obtained using the conversion cookie is used to create conversion statistics for AdWords customers who have opted for conversion tracking. Customers learn the total number of users who clicked on their ad and were redirected to a page tagged with a conversion tracking tag. However, they do not receive information that personally identifies users.
